### What is CRConnect?

- Clinical Research Connect (CRConnect) is a workflow system developed by the SOM Deans Office to assist staff with the study start-up process.
- It outlines all of the compliance requirements (IRB, Grants & Contracts, Investigational Pharmacy, InfoSec, HIRE, etc) and collects the required documents.
- Web-based application that will be required for all IRB-HSR submissions.

### **CRConnect Benefits**

- Collaboration with the study team
- Access most updated information/ documents
- Specific, protocol related compliance requirements can be seen
- Interface/ communication with the IRB-HSR and other regulatory authorities (HIRE, InfoSec, IDS, etc)
- Single Submission/Tracking # for IRB-HSR



### **CRConnect Benefits**

- Automatically generates forms and documents
- Uses DocuSign for electronic signature (by PI and Dept Chair)
- Email notifications regarding status of various steps
- Study team and other regulatory groups (IDS, InfoSec, etc) can access current documents
- Able to see the current status of all submissions to regulatory teams



### **Rollout Plan**

- Implementation groups identified by Steering Committee
- Groups contacted to provide specific department contact information
- Training for all users by the CRConnect Support team
- Once trained, users will be granted access and all future submissions to IRB-HSR are required to be through CRConnect
- Roll-out complete by December 2019


